# **Terms of Use**

Welcome to "Real Manager" - Fantasy Soccer League Game (the "Game") operated by Proyoli Gaming Ltd. (the "Company").

Each participant in the Game (hereinafter "you" or " <u>User</u>") receives upon registration an imaginary budget for assembling a soccer team consisting of between 14-16 players. The User's team will accumulate points based on real results and achievements of its players in the league, and compered to other participating teams of other Users, all in accordance with the rules of the game (the "<u>Rules</u>") which you can find here

Furthermore, each User can purchase virtual tokens with which he can invest in managing and improving his team. The purpose of the Game is to gain the highest number of points comparing to other Users' teams.

The participation in the Game shall be in accordance with and subject to the Rules and these Terms of Use, as shall be updated from time to time.

The registration and participation in the Game is free and is not subject to or conditional upon any entry fees. The Game does not involve any kind of betting, gambling, and/or actual cash out features.

#### **GENERAL**

The registration and participation in the Game are subject to: (i) these Terms of Use; (II) the privacy policy of the Game, available <a href="here">here</a> (the "Privacy Policy"); and (iii) the cookies policy of the Game, available <a href="here">here</a> (the "Cookies Policy"). The Terms of Use, the Privacy Policy and the Cookies Policy shall be hereinafter collectively referred to as the "Terms of Use".

The use of the Game in certain countries may be subject to terms of use and/or privacy policies of third parties with which the Company engages from time to time, such as sponsors and/or partners whom through their sites or assets, the Game is operated and/or partners that uses the Company's site or the Game for marketing and advertising purposes and/or partners that advertises the Game outside of the Game or the Company's site (collectively hereinafter referred as "Local Partner(s)"). In such case, such applicable third-party terms shall be presented for your approval on the registration screen and shall be deemed part of the Terms of Use for all intents and purposes.

You hereby confirm that you are at least 13 years of age. If you are under the age of 13, please do not register to or use the Game for any purpose. If you have reached 13 years of age but have not yet reached 16 years of age (hereinafter: "Minor"), please read these Terms of Use carefully and meticulously together with your parents and/or your legal guardian (the "Parent") and obtain their consent to register and use the Game. If you are a Minor, as precondition to your registration you will be requested to provide the name and e-mail address of the Parent who approved your registration and use of the Game, and subsequently, a verification e-mail will be sent from to the

Parent's e-mail address provided, while your account shall be activated only after your Parent verifies and approves by e-mail being your Parent and provides his consent for your registration and use of the Game. The Company may take other reasonable steps in order to verify the responsibility of the Parent and his approval for your registration and use of the Game. If you, or one of your Parents or legal guardians do not consent to all or part of the Terms of Use, you will not be allowed to register, and consequently to participate in the Game for any purpose. All personal data entered and collected from inactivated accounts of unauthorized Minors will be immediately deleted in the event that the consent of the Parents is rejected by the Company, at its discretion, and/or insofar as the Parents' approval has not been verified as required within 21 days of the date of sending the verification e-mail.

Without derogating from the forgoing, by using and participating the Game you hereby confirm that you have read the Terms of Use, understand the content hereof, and consented to be subject to the same.

#### RESTRICTIONS OF USE

The use of the site and the Game shall be made for a personal purpose only and shall not be used for any commercial purpose or use that includes a public display or screening of the Game in a public place, including any use aimed at generate profits, either directly or indirectly.

All data and contents displayed in the Game, including without limitation, images, player names, team names, team symbols and logos, team uniforms, design and any other materials displayed on the Game or the site (collectively referred herein, the "<u>Materials</u>") are materials owned by the Company and/or Local Partners, as the case may be, and which are protected, inter alia, by copyright laws, and shall not be used except in the framework of the Game and in accordance with the provisions of these Terms of Use.

#### REGISTRATION FOR SERVICES

Some of the services on the site, including the use of the Game, require registration. As part of such registration you shall be required to provide certain personal information, such as your full name, date of birth, country of residency, e-mail address, favorite soccer team, etc. In addition, as part as your use of the Game, Company may collect data from you about the place from which you are registered. In case you will connect the Game via your Facebook and/or Google account, we will receive your Facebook/Google ID number, data regarding your gender and Facebook/Google ID numbers of your Facebook or Google friends (as applicable). Furthermore, in such case of registration via Facebook/Google, we may use your profile picture displayed on such platforms in the context of certain social features included in the Game. The collection of the personal information is carried out by us only as necessary and relevant so that we may provide you with a high-quality Game experience. Moreover, we may use your personal

information only for the specific purposes for which you shall provide the same to us and the Company shall process said information in a lawful and transparent manner and in accordance with the Privacy Policy and any applicable data privacy laws and regulations.

Upon registration to the Game and as condition thereto you undertake to provide only correct, accurate and complete information. You undertake not to use and/or to connect and/or to set up a user account for any unlawful use and/or in such manner that violates these Terms of Use. Furthermore, you undertake that you will not set a fictitious user account and/or open a number of accounts linked to the same e-mail and/or open multiple user accounts with similar and/or offensive username. The Company reserves the full right to block and/or to remove users who, at the sole discretion of the Company, violate these Terms of Use and/or the Rules.

You bear the full and sole responsibility for maintaining confidentiality of your account password and for all actions carried out with or under your personal username and password. If you will elect to share this information with any third party, you shall bear liability for all actions that will be carried out using your information. In any event, the Company and/or anyone acting on its behalf, and/or the Local Partners shall have no liability for unauthorized use of your information by any third party.

Without derogating from the Privacy Policy provisions, upon your registration to the Game you are giving your consent and permission to the Company and anyone acting on its behalf and/or to the Local Partners to publish in your name and/or your photo and/or any other detail known to the Company in any media, all subject to and in accordance with the Privacy Policy. In case you will withdraw your consent to the aforesaid at any time, the Company may, in is sole discretion, revoke your eligibility for winning a competition. Furthermore, by using the Game constitutes your consent to the Company, to anyone acting on its behalf and to the Local Partners, to access, use and publish your details appearing on the relevant social network, including your name and your profile picture, all in accordance with and subject to the Privacy Policy.

# **USE OF SERVICES ENTAILING PAYMENT**

Some of the features offered on the site, including participations in certain contests within the Game, may or may hereafter entail payment. Such payment shall be executed using a PayPal account and/or an appropriate clearing services provider that shall be selected by the Company in each relevant country from which the payment is executed (hereinafter, the "<u>Clearing Corporation</u>"). Personal details required for executing the purchase shall be provided by you directly to the Clearing Corporation's site and shall not be retained in the systems and database of the Company. By executing a purchase, you are declaring that the credit card details provided by you upon purchase are true, correct and valid and that you are authorized to debit the PayPal account and/or the respective credit card through which the payment shall be made. The Company and/or anyone acting on its behalf or empowered by it, shall be allowed to collect from you, in any lawful manner it deems necessary, any charge that has been declined on your credit card and/or PayPal or other Collection Corporation account, in which case, you may also be charged for handling and legal fees and costs that may be imposed on your debt.

The Company and/or the Clearing Corporation may decide not to accept any payment from you, at their sole and absolute discretion, including, but not limited to, in the event that the registration details provided by you are incorrect or incomplete or when there is a reasonable suspect that you have violated the Terms of Use.

The Company and/or anyone acting on its behalf and/or the Local Partners are not and shall not be liable for any default, problem, malfunction and/or damages caused to you and/or anyone on your behalf as a result of execution and/or collection of payments. By accepting these Terms of Use you hereby understand and agree that any problem and/or malfunction and/or claim in connection with the foregoing, shall be directed solely to and of the direct responsible of the applicable Clearing Corporation.

In case that a purchase is successfully executed by you, however not recoded in the systems of the Company following at least 4 hours from the time of executing the purchase, please contact the Company in one of the ways listed below under these Terms of Use.

Subject to any applicable consumer protection laws and regulations governing the terms under which you may be able to cancel transaction, after being purchased or recorded by the Company's system, you shall have no option to convert virtual Game tokens, or other Game elements back into money. In this respect, the Company shall have the sole discretion to determine, whether or not certain purchased elements have been used or not. For Game purposes and general fairness, virtual Game tokens and other Game elements purchased by you during and in the course of certain Game season, shall be available for your use only for that specific season in the course of which they were purchased, and shall not be carried out with you for additional season(s) and/or any further contest, whether such have been fully used or not.

#### INTELLECTUAL PROPERTY

#### PROHIBITED ACTIONS

#### LIMITATION OF LIABILITY

The Company and/or anyone acting on its behalf (including its Local Partners and the soccer teams participating on the relevant league) shall not bear any liability under any circumstances and by virtue of any contractual, tortious grounds or any other grounds, toward you or toward any other person in respect of any cost or damage, direct or indirect, special, punitive or incidental compensation of any kind (including, without limitation, damages in respect of impairment of goodwill, loss of data or information, loss of profits, work stoppage, crash or any other problem involving a computer and/or any device used on the site or in the Game, business interference, etc.) resulting from the use or from the impossibility of using the site or any part thereof, even if the Company or anyone acting on its behalf have received notice of the possible existence of such damage. You hereby exempt the Company and all the aforesaid on its behalf from any liability as set forth in this paragraph.

Without derogating from the generality of all the aforesaid, it is hereby clarified that any limitation of liability applicable to the Company pursuant to these Terms of Use, shall also apply to its local Partners.

# **ADVERTISEMENTS, LINKS AND REFERENCES**

On the site and in particular the Game, you may be exposed to advertisements, links and references, including to links for external websites, to other information sources, or from other commercial entities, organizations and companies. The Company has a very limited control and has no means to oversee all the advertising contents, the type of links and particularly the external contents displayed when entering the same.
